Sales Contract for Photographic Products, Terms and Conditions of Sale

This Sales Contract is made effective as of the date noted on the front of this Sales Contract, by and between Wolf Creek Images, LLC., DBA Beachside Photography, with offices at 1269 Whitewood Way, Niceville, FL, 32578, hereafter referred to as "Photographer" and the customer identified on the front of this Sales Contract, hereafter referred to as "Client".

1. **Items Purchased**, Photographer agrees to sell and Client agrees to buy, products (the "Goods") as identified and listed on the front of this Sales Contract, in accordance with the Terms and Conditions of this Contract.
2. **Product Standards** shall meet or exceed industry standards for photographic quality consistent with other service providers in the community and region, and in accordance with special instructions as listed on the front of this Sales Contract.
3. **Title/Risk of Loss**, Client shall pay reasonable shipping costs, but Photographer shall be responsible for packaging, shipping and safe delivery and shall bear all risk of damage or loss until the goods are delivered to Client's address.
4. **Payment** shall be made in full at time of the Sales Contract and prior to any additional work being performed in the completion of this Sales Contract.
5. **Delivery** shall be made within 4-6 weeks from the date of this Contract.
6. **Payment of Taxes**, Client agrees to pay Florida sales taxes, and any other applicable tax, excluding income tax.
7. **Editing**, all purchased images will be edited by the Photographers with Lightroom or Photoshop software programs. Standard edits will include corrections and adjustments to exposure, color balance, clarity, contrast, and crop. Additional edits such as head swaps, thinning of person, removal of persons/buildings, open of eyes, or other enhancements are subject to additional charges as agreed to and noted by the Sales Contract. The quality of all edits shall be the judgment of the Photographer and shall meet or exceed standardizes used by other service providers in the community and region.
8. **Rights**, All images and rights relating to them, including copyright and ownership rights in the media in which the images are stored, remain the sole and exclusive property of Photographer, unless otherwise specifically provided for in the form of a Copyright Release given to the Client. This prohibition includes any rights or privileges that may be claimed under s201(c) of the Copyright Act or 1976 or any similar provision of any applicable law. Digital files may contain copyright and other information embedded in the header of the image file or elsewhere, removing and /or altering such information is strictly prohibited and constitutes violation of the Copyright Act. Unless specifically provided elsewhere or by Copyright Release, no reprographic, reprint, republication or other secondary reproduction usages may be made, and usage rights are granted only for personal usage and cannot be used in any commercial publication or promotional materials. The Photographer retains the right to use images for its own promotional materials and websites without limitation.
9. **Indemnification**, Client agrees to indemnify and hold harmless Photographer from all claims, losses, expenses, fees, including attorney fees, and judgments that may be asserted as a result of this Sales Contract.
10. **Warranty**, Photographer shall provide its services and products to meet its obligation under this Sales Contract in a timely and workmanlike manner, using knowledge and skills required for performing to a generally acceptable standards and will provide a standard of care equal to, or superior to, care used by other service providers in the community and region.
11. **Default**, The occurrence of any of the following shall constitute a material default under this Sales Contract:
 - a. The failure to make a required payment.
 - b. The insolvency or bankruptcy of either party.
 - c. The subjection of any of the either party's property to any levy, seizure, general assignment for the benefit of creditors, application or sale for or by any creditor or government agency.
 - d. The failure to make available or deliver the Goods in the time and manner provided for in this Sales Contract.
12. **Remedies on Default**, In addition to any and all other rights available according to law, if either party defaults to substantially perform any material provision, term or condition of the Sales Contract, (including without limitation the failure to make a monetary payment when due), the other party may elect to cancel this Sales Contract if the default is not cured within 30 days after providing written notice to the defaulting party. This notice shall describe with sufficient detail the nature of the default. In event of Photographer default, the Client is entitled to a complete and full refund of all payments made up to the date of default, payable within 30 days of the written notice of default.
13. **Limit of Liability**, shall be limited to the value of this Sales Contract. In no event will Photographer be liable for any lost or expense, incidentals, indirect, special or consequential damages, arising out of this Sales Contract.
14. **Force Majeure**, If performance of this Sales Contract is prevented, restricted, or interfered with by causes or events beyond either party's reasonable control, and if the party unable to carry out its obligations gives the other party prompt written notice of such event, then the obligations of the party invoking this provision shall be suspended to the extent necessary by such event. The excused party shall use reasonable efforts under the circumstances to avoid or remove such causes of non-performance and shall proceed to perform with reasonable dispatch whenever such causes or event is removed or ceased.
15. **Entire Contract**, This Sales Contract contains the entire agreement of the parties regarding the subject matter of this Sales Contract, and there are no other promises or conditions in any other agreement whether oral or written. This Sales Contract supersedes any prior written or oral agreements between the parties.
16. **Amendment**, The Sales Contract may be modified or amended if the amendment is made in writing and agreed to by both parties.
17. **Waiver of Contractual Right**, The failure of either party to enforce any provision of this Sales Contract shall not be construed as a waiver or limitation of the party right to subsequently enforce and compel strict compliance with the every provision of this Sales Contract.
18. **Dispute**, in the event of a dispute, both the Photographer and Client agreed to make reasonable efforts to resolve the dispute by and in the order of:
 - a. Mutual Agreement
 - b. Arbitration in the Photographer's City and State
 - c. Small Claims Court in the Photographer's City and State
19. **Applicable Law**, The Sales Contract shall be governed by the laws of the State of Florida
20. **Acceptance**, of the terms and conditions of this Sales Contract shall be assumed by both parties by the payment and acceptance of the fees identified on the front of this Sales Contract.
